Promotion Rules "Pay with Auto Card - Get an iPhone 14 PRO"

- 9. The Promotion Period: from 00:00 a.m. on 14 November 2022 to 11:59 p.m. on 22 January 2023 (hereinafter referred to as the Promotion Period).
- 10. Terms of participation in the Promotion:
 - 10.1. Be a holder of a valid MASTERCARD payment card from Eurasian Bank JSC;
 - 10.2. During the Promotion Period, make a transaction with a MASTERCARD card from Eurasian Bank JSC:
 - The number of transactions is unlimited;
